All first-place entries will be placed into a final stage of judging, with a grand prize ribbon given to the best of show.

**JUDGING:** All entries must meet the requirements of the category entered. Recipes not meeting contest entry criteria will be disqualified. Entries will be judged in the following criteria:

- Appearance (maximum 10 points)
- Taste (maximum 10 points)
- Creativity (maximum 10 points)

- Items must be delivered between 6:00 p.m. & 6:55 p.m. on Wednesday, June 10<sup>th</sup> to the Arts and Crafts Building to be registered in a disposable container. **The items become property of the VA/KY District Fair and may not be retrieved.**
- Winners will be announced at approximately 9 p.m.
- No identifying labels are permitted on any item
- Baking Contest Officials have the right to accept, reject, and classify entries in accordance with the rules.
