## Rules & Regulations

- The VA-KY District Fair & Horse Show Committee or any employee of the show or committee will not be liable nor responsible for injury to any person or animal, or for damage to loss of property on the show grounds.
- Everyone entering the show grounds must pay admission. No coupons will be issued. No gate refunds will be made.
- Disrespect or discourtesy toward any show official will not be tolerated. Offenders will be escorted from the show grounds. The horse show management reserves the right to decline any entry.
- Five entries are required to constitute a full class. If less than five horses are entered, prize money will begin with second place. Classes of three or less will begin with third place money. Pay Back Chart
- Due to time restrictions no classes will be added.
- Three-minute gate call in all classes.
- Juvenile classes 17 years and under unless otherwise stated. Pursuant to association rules, helmets are not required, but can be worn at the discretion of the applicant.
- No one will be allowed to enter the ring except grooms, riders, and judges or assistants. Upon entering the ring horse and exhibitor are under control of the judge and are subject to their instructions. Decisions by the judge and the VA-KY District Fair Horse Show Committee are final. Any protest must be submitted in writing along with a \$100 cash deposit.
- Twelve-month negative Coggins test will be required at the gate.
- All pacing classes, horses passing on a slow pace will not be judged. Passing is allowed only at a fast pace. Must enter the ring at a walk, otherwise you will not be judged.
- A Two Class Notice is required before any registration refunds will be issued.
- Any announcement made the day of the show takes precedence over printed material.
- No padded horses allowed.
- No Blinders allowed.
